Using Fiske Affiliate Status at FamilySearch

I had the pleasure of trying out our new Affiliate Status for FamilySearch.org during a recent visit to Fiske Library. I was looking for a microfilm copy of original Kirk Session records for a church in Scotland. I had spotted a reference to this film in the FamilySearch Wiki for genealogy research in Paisley, Scotland:

Records—FS Library Film Number: Session Minutes 1783–1804, 1818–1848 1886234 items 5–7

I brought my laptop and linked it to the Fiske network for internet access. You can use the library computer if you don't have a portable system. Bring a thumb drive if you want to download items browsed on the library computer.

Opening my browser I went to FamilySearch.org and logged in with my personal FamilySearch account ID and password. I then clicked on the "Search" tab and "Catalog" in the sub-menu.

I had the option of searching by Place or by Film Number.

Trying Place, I wrote "Paisley" but that did not work. The program suggested "Scotland-Renfrew-Paisley" which worked.


Alternatively, I could click on "Film/Fiche..." and put in the film number I had from the FS Wiki: 1886234

Clicking the "online" option reduces the number of hits returned.



Searching by "Place" or by "Film Number" ultimately brought me to "Church records for the Canal Street Church, Paisley, 1783-1868." Scroll down to the "Film/Digital Notes:"

Click on the camera icon and you go to the microfilm page.

If you try this from home, the "key" above the camera icon will result in a page that looks like this:



BUT now that Fiske is an Affiliate Library, this page will show a series of original MSS photos which you can enlarge and read. NOTE: These images are under copyright or other restrictions, so if you download anything, do not post the images online [on Ancestry, social media etc.]

My particular film had two different sections, one for a Milnathort church and one for the Canal St. church. There was no index and the first time through, I had to scroll half way through the reel before I found my desired pages. However, making note of the "image number" I have been able to return directly to where I left off in subsequent visits.

When using FamilySearch at home, any time you run across an item where an image is available but you are not allowed to view it, remember that a visit to Fiske can solve that problem. Using our network and FamilySearch affiliate status, you can access nearly everything.

Internet Archive Lawsuit

The Internet Archive is an invaluable resource for online research for genealogists. It has amassed an amazing collection of genealogy resources among other works. Most of the genealogy works are in the public domain, but the Archive has also made copyrighted material available with limitations.

The Internet Archive has been under fire since 2020 for how it manages its lending policies. Four major publishing companies sued for copyright infringement. The Archive argued "fair use" and the importance of public access to library materials. Recently, the Internet Archive lost the lawsuit, although it plans to appeal.

Although the publishers made legitimate points due to changes in access the Archive made during the pandemic, there are real concerns about digital library access across the board, particularly at a moment in our history when libraries in general are facing censorship and book banning.

1931 Canadian Census

On June 1, 2023, the Canadian government released digitized records of the 1931 Census of Canada. Following the release, nearly 235,000 images were made available to browse on the <u>Library and Archives Canada (LAC) website.</u>

However, the response was so large that the website broke down. The latest word is: "Our search engines, including the one for browsing the 1931 Census, are slower than usual and, in some instances, images may be unavailable. We appreciate your patience while we are working on restoring the situation."

LAC plans to partner with Ancestry® and FamilySearch International to read the images using Ancestry's state-of-the-art handwriting technology. These collaborative efforts will create an advanced searchable database of records of Canadian residents.

War of 1812 Records

Per Fold3 article May 25, 2023:

Ancestry® and the National Genealogical Society® have finalized a contract with the National Archives and Records Administration (NARA) to resume digitization of the War of 1812 Pension Files. This ongoing project came to a halt during the closure of NARA due to COVID-19.

The project to digitize this collection began in 2010 and 83% of these records had been completed before the stoppage. "We're just finishing up the final files for surnames beginning with 'R' and will move on to files with surnames beginning with the letters 'Sj to U' next." These digitized records are available to view for **free** on Fold3®.

The referenced article gives details on how to access the collection.
